- ** Enrollee of Martial Arts should take promotion tests upon recommendation of the Instructor.
- ** Uniforms, seminars, testing, tournaments, etc., are separate fees not included in the terms of this agreement.
- ** Buyer agrees to make installment payments to the Amerinational Management Services, Inc. in Orlando Florida.
- ** This agreement comprises the entire agreement pertaining to membership, and no other agreement of any kind will be recognized by us.

** CONSUMERS RIGHT OF CANCELLATION **

**You may cancel this agreement penalty free within 3 days of execution date of this agreement, exclusive of holidays and weekends upon mailing or delivering written certified notice of cancellation to above address. This agreement may be canceled as to the affected person for reasons of death or substantial disability by providing a death certificate or disability statement by a certified physician. You may cancel this agreement if the center goes out of business and fails to provide facilities within a 5 mile radius of, or moves its facilities more than a 5 mile radius from, the present facility. Agreement may not exceed 36 months.

SECTION III

This Agreement executed the date shown front by and between **(MOUNTAIN KIM MARTIAL ARTS XSP)** hereinafter referred to as the Center, and the buyer, who has caused his/her signature to be affixed hereto, hereinafter referred to as Enrollee or Buyer.

The Center agrees to provide instruction in Martial Arts to the enrollee during the scheduled instruction hours of the Center. Enrollee understands that it is his or her responsibility to attend instruction sessions. **Enrollee understands that the entire course fee stated front is due and payable according to the terms of this agreement whether or not enrollee chooses to attend instructional sessions provided by the Center.** In consideration for the Center's promises to instruct and provided instruction facilities, Enrollee agrees and promises to pay the course fees shown on front.

In the event of default in the payment of any installment or fee in accordance with the terms above, or a breach of any of the covenants herein contained to be performed by the Enrollee, the balance due under this agreement shall become immediately due and payable.

Enrollee agrees to abide by the rules and regulations governing the conduct and operation of instruction sessions, students, and observers, in order to promote efficiency, safety, and recognition of the instruction certification, as prescribed by the Center. Enrollee acknowledges that rules and regulations governing the Center have been adopted, and may be changed from time to time, and Enrollee agrees to abide by all such rules and regulations as adopted or hereinafter amended. The hours of operation may be changed at the discretion of the Center.

The Center reserves the right to revoke or terminate any membership.

Enrollee agrees that all exercises and/or courses are undertaken at members own risk. The Enrollee understands the procedures and exercises involved in instruction and participation as explained to him/her by an assistant of the Center. The Enrollee understands that there is a risk of personal injury involved in the course of instruction and with this knowledge agrees to indemnify and save harmless the Center from all losses caused by accident or injury to the Enrollee, or to third persons, who may be with Enrollee of the Center, in the event that either the enrollee or said third person is injured in any way during the performance and execution of exercises.

The company owning the Center and the agents and employees shall not be responsible for damaged, lost or stolen articles, inside or outside the facility.

The Center reserves the right to amend or add to these rules and conditions and to adopt new rules and conditions as it may deem necessary.

If an Enrollee desires to transfer his/her membership to another individual, a transfer fee will be assessed to cover our costs which will not exceed \$35.00. Memberships obtained on a special are not transferable or freezable. Enrollee may not transfer membership without approval from Mountain Kim Martial Arts.

I, the Enrollee or the Member, irrevocably authorize the Center, its successors and assigns, and those acting under its authority, to copy, use, publish, for art, advertising, trade, or any other lawful purpose whatsoever, photographic portraits, pictures or videotapes of me, in which I may be included in whole or in part.

In consideration of the training obtained, I agree that I will not, during the continuance of this agreement, and for a period of five (5) years following termination of my association with the Center, engage in teaching Martial Arts or offering similar training or instruction within a ten (10) mile radius of any school operated by the Center without the express written authorization of same.

Should you (the buyer) choose to pay for more than one (1) month of this agreement in advance, be aware that you are paying for future services and may be risking loss of your money in the event this Center and/or this business location ceases to operate. This Center is not required to provide any security, and there may not be other protection provided to you should you choose to pay in advance.

Members/Enrollees who pay the course fee in full may not be refunded any amount in any circumstance after three (3) days unless expressly written otherwise by a Mountain Kim representative.

With 90 days notice, Enrollee may cancel this agreement with written US Military orders that indicate enrollee is required to move at least 20 miles from the location enrolled.

After School Members (AMP) may pay a cancellation fee of \$500 at anytime to cancel their agreement.

Enrollee in traditional Taekwondo may cancel their membership agreement due to hardships disclosed to Mountain Kim by paying a penalty fee equal to 50% of the agreement balance. **Black Belt Club (BBC) or Masters Club (MC) agreements are not cancelable; this includes AMP members as well.**
